Highlights

Received our 2nd SAMHSA grant.

The Behavior Clinic expanded services into Waukesha County.

Birth to Three services were able to safely resume in-home services in July 2021 and while this remains our primary service delivery model, we are creating a new blended service delivery model that meets families' needs by offering accessible in-person and telehealth services.

Our Programs

In 2021, Penfield served 1,380 children and 84% of these children lived at or below the federally-defined poverty level.

Behavior Clinic

 The Behavior Clinic served 227 children ages six and younger in Milwaukee County.

- 88.4% of families showed an **increase in parent-child relationships** based on the Parent-Child Relationship Scale.

 69.4% of children showed a reduction in challenging behaviors based on the Early Childhood Behavior Screen.

Early Education and Care

- Our Early Education and Care program served 87 children.

 — 88.1% of our children demonstrated progress in socialemotional objectives, such as regulating emotions and behaviors, forming positive relationships, and participating in group activities.

- 93.2% of our children progressed in physical development, such as traveling, balancing and gross-motor manipulative skills and fine-motor strengthening/coordination.

 Approximately 40% of children in our Early Education and Care program have a disability or developmental delay, such as cerebral palsy or autism.



Special Care Nursing Services

- 47 children received Special Care Nursing Services and our registered nurse provided 780 nursing contacts for infants and young children, such as a medical appointment, nursing assessment, or medication management.

- 100% of parents with children who required skilled nursing services **received support from Penfield's nursing team**. This support included hospital and home visits, phone calls, consultations, and more.

96.3% of children who received nursing services improved their cognitive and motor skills.

Milwaukee County Birth to Three Early Intervention Services at Penfield

- 940 children received Birth-to-Three services from Penfield staff.

- 97.22% of children **displayed developmental improvement in motor skills** and 95.41% of children improved in cognitive skills.

- 94.5% of children displayed signs of **developmental** improvement in communication skills.



Through generous support from Kohl's Cares, the Kohl's Building Blocks program helps Penfield Children's Center support children throughout Milwaukee County in Wisconsin. This comprehensive program gives children in need access to early educational and developmental programs, services and equipment.

Family Impact



Desly is dancing to music when we walk through the kitchen to the living room to join her. Her petite frame moves joyfully to the music and her little ponytail bounces freely atop her head. Desly's mom, Autumn, **uses music and movement to help guide her daughter through the transition of switching activities**, a skill she learned from Stephanie, their Birth to Three Primary Service Provider. The song ends and everyone sits around a pile of books on the floor. The energy in the room is filled with warmth, comfort and calm - like bumping into a friend you haven't seen in a while.

At Desly's two year old check up, Autumn noticed her daughter was behind on her speech milestones and was referred to the Milwaukee County Birth to Three Program. When choosing to move forward with this program Autumn says **she was drawn to the program because services are performed in-home** vs a clinic setting. Having sessions at home, where Desly was comfortable, provided an additional level of comfort for their family.

The conversation flows naturally as Autumn shares recent situations and outcomes while Stephanie asks questions and provides insight. Talking through these moments, updating on new skills and recounting recent struggles is a valuable part of each therapy session. Stephanie and Autumn "troubleshoot" together why certain activities went well or not so great. Stephanie coaches Autumn on techniques and activities to try and is her biggest supporter in pointing out skills that Desly is displaying. Autumn beams as she recounts the growth in her daughter's overall confidence since they have been involved in the birth to three program. She shares moments where Desly is becoming consistent in using words like "no" and "ready, set, go" and finding success utilizing transition techniques to ease from one activity to another. Autumn shares how Desly has even started engaging, in small ways, with other children at the park.

As Desly turned three, and Birth to Three Services ended, Autumn reflects on how the experience truly helped their family. Looking back, her only wish is that they would have started sooner. As part of the transition process Stephanie helped Autumn navigate through education evaluations and IEP planning, even going along with her and Desly to the evaluations.

Desly quietly flips through some books, turning the pages, taking in the pictures and often flashing her eyes upwards to engage Stephanie. She smiles and giggles, as together they count how many crocodiles are on the page. The trust and connection between Stephanie, Desly and Autumn is a major component



of the birth to three programming. Teaching skills, techniques and providing support to parents allows for consistency, routines and the opportunity to strengthen skills in everyday life.




